WASTE SOURCE Magnox skips arise from the transport and pond storage of Magnox fuel elements.

Comments on planned treatments:

Empty skips are currently sent to WAGR Box Store for buffer storage, prior to size reduction at the SSRF, followed by interim storage in MBGWS. There are potential opportunities for size reduction at the DWSP and off-site metal treatment.

Conditioning method:

Skips destined for MBGWS are size reduced in SSRF to fit 2 size reduced skips into 1 intact skip, for placement of 3 skips in an MBGWS box. Final conditioning method and container for final disposal have not yet been decided.
