RADIOACTIVITY

Source: The activity has arisen primarily from Magnox and THORP reprocessing and is associated with PCM. The waste covered by this stream has become contaminated during operation of the compaction facility and the associated stores.

Uncertainty: The uncertainty associated with the derived fingerprint is likely to be relatively low, however the volumes and total activity information (and possibly some other assumptions) are likely to be more notional and thus more uncertain.

Measurement of radioactivities: Specific activity data is based on data in the corresponding WCH, which in turn maps an estimated total activity and a derived radionuclide fingerprint (which is largely based on the fingerprint for 2x02).
