This waste stream also covers waste generated by transportation logistics from the railway lines and the Railways Monitoring facility.

RADIOACTIVITY

Source: The activity arises as a result of operations to decontaminate flasks and originates from the fuels these flasks were used to transport.

Uncertainty: The uncertainty associated with the derived fingerprint is likely to be relatively low, however the volumes and total activity information (and possibly some other assumptions) are likely to be more notional and thus more uncertain.

Measurement of radioactivities: Specific activity data is based on data in the corresponding WCH, which in turn maps an estimated total activity to a derived radionuclide fingerprint (which has been derived based on the fingerprints of the donor areas and weighted by the number of flasks expected to be consigned from each area).
