Source: The activity is expected to arise from various facilities in the separation area. The waste covered by this stream will become contaminated during routine operations and maintenance.

Uncertainty: The uncertainty associated with the derived fingerprint is likely to be relatively low, however the volumes and total activity information (and possibly some other assumptions) are likely to be more notional and thus more uncertain.

Measurement of radioactivities: Specific activity data is based on data in the corresponding WCH, which in turn maps an estimated total activity to a derived radionuclide fingerprint (which is based on the weighted fingerprints for various streams).
