Additional information on quantities: Uncertainty information is notional. Note that while the current plan is for active items to be laundered off-site, there is a risk that this may not be possible, in which case replacement facilities would be required (hence the high upper uncertainty).

RADIOACTIVITY

Source: The activity is associated with the decontamination of laundry waste and originated from various areas of Sellafield site. The waste becomes contaminated during routine operations and maintenance.

Uncertainty: The uncertainty associated with the fingerprinting analysis is likely to be low, however the volumes and total activity information (and possibly some other assumptions) are likely to be more notional and thus more uncertain.

Measurement of radioactivities: Specific activity data is based on data in the corresponding WCH, which in turn maps an estimated total activity to an analytically derived radionuclide fingerprint.
