RADIOACTIVITY

Source: The activity has arisen from historical operations associated with the Uranium Import and Handling area within the SMP. The original source of the activity is the uranium dioxide that was received and processed. The waste becomes contaminated during preparations for care and maintenance.

Uncertainty: The uncertainty associated with the fingerprint is likely to be relatively low, however the volumes and total activity information (and possibly some other assumptions) are likely to be more notional and thus more uncertain.

Measurement of radioactivities: Specific activity data is based on data in the corresponding WCH, which in turn maps an estimated total activity to a derived radionuclide fingerprint.
