Source: The activity has arisen from historical operations within SMP. The sources of the activity are uranium and plutonium oxides from MOX Fuel production.

Uncertainty: The uncertainty associated with the fingerprint is likely to be relatively low, however the volumes and total activity information (and possibly some other assumptions) are likely to be more notional and thus more uncertain.
