Measurement of radioactivities: Some specific activities have been estimated using a neutron activation calculation using available material specifications. The major source of uncertainty is the impurity levels. The activities quoted are those at 72 years after reactor shutdown, i.e. in 2060. There may be some contamination by Cs137.
