Source: The waste is exhausted desiccant and catalyst from the reactor gas drier system. The main source of activity is from tritium. Mn 54 and Fe 55 may be present in trace quantities. Specific activity is a function of operating history. Stock activity decayed to 01-04-2025.

Uncertainty: Activity estimates are considered to be accurate to a factor of 10.

Measurement of radioactivities: Activities have been measured.

Chemical form of radionuclides: H-3: Tritium is expected to be present as water. Some may also be present in other inorganic or organic compounds.
