PHYSICAL CHARACTERISTICS

General description: Shield cooling filter elements about 0.5 m diameter x 2 m long and weighing ~0.2 t. The filter elements are double wrapped in polythene. Special handling requirements have not been assessed. Items are about 0.5 m diameter x 2 m long and weigh ~0.2 t.

Bulk density (t/m³): ~ 0.50

Comment on density: The bulk density of the waste is about 0.5 t/m.

CHEMICAL COMPOSITION

General description and components (%wt): Air filters consisting of rolls of glass fibre (9%) on metal spindles (90%). Chemical compositions not fully assessed. Polythene wrapping material (~1%).

Chemical state: Neutral

Sheet metal proportion / thickness: The waste includes metal spindles which are about 2 m long. These spindles are expected to be disposed of as non-active waste.
