WASTE SOURCE Sand and gravel from sand pressure filters in the Active Effluent Treatment Plant. Sludge and solids are removed by mechanical filtration through a mixed bed of sand and gravel which is then backwashed into sludge tanks. The filters will be emptied of sand and gravel when the plant is decommissioned.
