RADIOACTIVITY

Source: Activation of the mild steel and its impurities.

Uncertainty: The values quoted were derived by calculation from available material specifications and are indicative of the activities that are to be expected. The major source of uncertainty is the impurity levels. There may be some contamination by Cs137. The activities quoted are those at 50 years after reactor shutdown, i.e. in 2040.

Measurement of radioactivities: The specific activities were estimated from neutron activation calculations of the material and its impurities.

Chemical form of radionuclides:

H-3: The tritium is incorporated in the steel.

C-14: The carbon-14 is incorporated in the steel. There also may be some contamination as graphite.

Cl-36: The chlorine-36 is incorporated in the steel.

Se-79: The selenium content is insignificant.

Tc-99: Technetium will be incorporated in the steel. It is an activation product of Mo-98.

I-129: -

Ra: The radium content is insignificant.

Th: The thorium content is insignificant.

U: The uranium content is insignificant.

Np: The neptunium content is insignificant.

Pu: The plutonium content is insignificant.
