Uncertainty: Only very approximate estimates have been made of the total specific activities. The activities quoted are those at the time of Reactor Dismantling & Site Clearance (50 years after Station shutdown).

Measurement of radioactivities: For the reactor materials the specific activities were estimated from neutron activation calculations of the material and its impurities.

Chemical form of radionuclides: H-3: The chemical form of tritium has not been assessed, but may be incorporated into the steel.

Cl-36: The chemical form of chlorine 36 has not been assessed.
