Comment on arising rates: Rate of arisings can not be estimated as the waste is stainless steel slag contaminated through accidental melts of radioactive sources that pass undetected through the scrap metal supply chain. The volume of waste has reduced as a result of disposal lower level contaminated waste and revised package assumptions.
