Decommissioning wastes will be generated following cessation of site operations in early 2028. The rate of arising will be dependent on the NDA future decommissioning programme.

Additional information on quantities: Existing stock is 17m3 to be disposed off late 2025. The rate of arising will be determined by the future decommissioning programme. Characterisation and fingerprint work is still to be carried out therefore there is a large uncertainty in the potential arisings.
