Uncertainty: Analytical results used in the 2004 Inventory gave an accuracy of 3 on the range of activities analysed to date. The Decay Calculation Tool in Brims was used to estimate the specific activities for stocks held in 2007; these were decayed by 6 years for stocks held in 2013. No further work completed since 2013. No change for 2025.

Measurement of radioactivities: The specific activities for future arisings have been cautiously assumed to be those quoted in the 2007 Waste Inventory. No change 2025
